Notice is hereby given that the 29<sup>th</sup> Annual General Meeting (AGM) of the Company will be held on Saturday, 27<sup>th</sup> September, 2014 at 10.30 a.m. at the Registered Office of the Company at Dempo House, Campal, Panaji-Goa 403001.

The Company has dispatched the 29<sup>th</sup> Annual Report of the Company for the year 2013-14 and the Notice of the 29<sup>th</sup> AGM to the Members at their addresses registered with the Company, as on 15<sup>th</sup> August 2014.

Pursuant to the provisions of Section 91 of the Companies Act, 2013, the Register of Members and the Share Transfer books of the Company will remain closed from Tuesday, 23<sup>rd</sup> September, 2014 to Saturday, 27<sup>th</sup> September, 2014 (both days inclusive) for the purpose of the 29<sup>th</sup> AGM of the Company.

- (iv) Voting through electronic means shall not be allowed beyond Monday, 22<sup>nd</sup> September, 2014.
