The Board of Directors of the Company has appointed CS. Sadashiv V. Shet, Practising Company Secretary (Membership No. FCS 2477, C.P No 2540), to act as the Scrutinizer for conducting the Postal Ballot process.

The Company has offered e-voting facility as an alternate, to enable the Shareholders to cast their votes electronically instead of dispatching Postal Ballot Form and has entered into an agreement with NSDL for the purpose. Members have an option to vote either electronically or by Physical Postal Ballot Form. The detailed procedure for e-voting is enumerated in the Notes to the Postal Ballot Notice.

Members are requested to note that the duly completed Postal Ballot Forms should reach the Scrutinizer not later than the close of working hours on Tuesday January 17, 2017. The voting period for e-voting module shall commence on Monday, December 19, 2016, (9.00 a.m) and will end on Tuesday January 17, 2017, (5.00 p.m). Any responses received after this date will be treated as if the same has not been received.

The copy of the Postal Ballot Notice is available on the Company's website **www.hflgoa.com**. Members, who do not receive the same by Registered Post, may download it from the Company's website or may request for duplicate Postal Ballot Form from M/s. Hindustan Foods Limited at: Dempo House Campal, Panaji, Goa 403001. Shareholders who have received Postal Ballot Notice by e-mail and who wish to vote through physical Postal Ballot Form can download Postal Ballot Form from the link www.evoting.nsdl.com or from the website of the Company **www.hflgoa.com**.

Shareholders can opt for only one mode of voting, i.e., either by Physical Ballot or e-voting. If shareholders are opting for e-voting, then do not vote by Physical Ballot or vice versa. However, in case Shareholders cast their vote by both modes, then voting done through e-voting shall prevail and the voting done through postal ballot shall be treated as
