Learned Counsel for the Petitioner Companies state that in pursuance of the directions contained in Order dated 26<sup>th</sup> April, 2021 passed by the National Company Law Tribunal, Mumbai Bench in the Company Application No. 1069 of 2020, meeting of the Secured Creditors of the First and Third Petitioner Company and meeting of Unsecured Creditors of the Petitioner Companies was dispensed with.
